## **Administrative Accomplishments as Provost and Executive Vice President, Colorado State University (January 2024 – Present)**

Inspired by its land-grant heritage, Colorado State University is committed to excellence, setting the standard for public research universities in teaching, research, service and extension for the benefit of the citizens of Colorado, the United States and the world. CSU strives to provide a high-quality, affordable higher education to all who have the desire and ability to achieve it. In fall of 2024, 34,218 total students were enrolled at CSU's main campus in Fort Collins. Research expenditures for 2023-2024 were \$576 million.

As Provost and Executive Vice President of Colorado State University, I lead the academic enterprise and serve as the #2 Administrative Officer to President Amy Parsons. I supervise 8 academic deans of colleges, the Dean of the Libraries, the Vice Provost and Dean of the Graduate School, and the Vice Provost and Dean of Undergraduate Affairs, as well as Vice Provosts for Faculty Success, Planning and Effectiveness, and International Programs. Three divisions and their Vice Presidents report to the Provost and Executive Vice President: Research, Enrollment and Access, and Student Affairs. Other units led by the Provost and Executive Vice President at CSU include the University Honors Program, Army and Air Force ROTC, and the Institute for Teaching and Learning (TILT). I serve as an Ex Officio Member of the Faculty Council Executive Committee, involving providing reports at their weekly meeting.

As Provost and Executive Vice President, my priorities are organized around those of President Parsons. All initiatives and accomplishments are the result of collaboration with excellent teams.

### **Student Success**

- Develop a distinctive academic mission and an innovative core curriculum for CSU – in collaboration with Faculty council, launched a Faculty Task Force in May, 2024 to revise CSU's Institutional Learning Objectives to highlight our distinctive academic missions then to create an innovative core curriculum to highlight distinctive academic missions of CSU: Democracy, Climate and Sustainability, One Health and Vital Longevity, Colorado, and more
- Develop a first-year program at Spur as a gateway to Fort Collins for urban students from Denver – launched and serve as Executive Sponsor for a Faculty Task Force to launch Spur Start in Denver in Summer, 2025
- Work with Enrollment and Access and Student Affairs on enhanced communication with students and families through the orientation process and through their time at CSU – Realigned orientation and transition programs to become part of the Division of Enrollment and Access in January 2025
- Leverage outcomes data and degree maps to improve course scheduling and program design and remedy courses with high DFW rate
- Collaborate with Enrollment and Access and Student Affairs to develop a Ram Transfer Academy to welcome more community college students to CSU – program launched in August 2025 in collaboration with Front Range Community College, CSU received a \$500 grant from the American Talent Initiative (ATI) to support this new program
- Restructure academic advising at CSU to create a higher standard of care, elevate and advance the professional status of academic advising, enhance coordination and communication of advising across colleges, and offer a career ladder and professional development for academic advisors- hired a new Assistant Provost for Student Success and Academic Advising who began November 1, 2024.
- Create a new Leading Edge Summer Bridge program for launch in Summer 2026 for first-year students focusing on foundational math and honors experiences – program to launch in Summer, 2026
- Enhance summer offerings, collaborate with Faculty Council and others on a possible Winter Session, to provide additional opportunities for student success and Study Abroad – in collaboration with Faculty Council, launched a Faculty Task Force on the Academic Calendar and Student Success
- Enhance the excellence of experiential education and more fully utilize remote campuses– SPUR, Todos Santos, Mountain Campus, Semester at SEA – highlight these distinctive assets in recruiting, collaborating with a Senior Vice President to develop a sustainable financial model

### **Strengthening our Democracy**

- Prepare students for a diverse and inclusive democracy, foster understanding of a diversity of ideas and identities in preparing students for a global citizenship, develop a DEI certificate for students, increase study abroad, international enrollment, and engagement between international and domestic students
- Build exciting engaging sessions on Democracy and Freedom of Expression into Ram Welcome – new modules launched in August of 2025
- Collaborate with faculty around curricular innovation uniting general education courses around the theme of democracy, so that all students take a course highlighting democracy, and some choose to orient their undergraduate core curriculum courses around this theme – faculty task force launched in May 2025
- Work with faculty to develop courses that use pedagogical strategies to foster civil discourse and the airing of diverse viewpoints, in collaboration with The Institute for Learning and Teaching (TILT)
- Continue to organize public events with faculty and university leaders debating key issues, modeling respectful disagreement, and airing of diverse perspectives, track engagement, invite students to join in planning and organization

### **World-Class Academic and Research Programs**

- Engaged Academic Analytics in March 2024, to understand how to strengthen departments and colleges to enhance the impact of CSU (and align with AAU metrics): provide support and encouragement for more faculty awards and work with VPR to provide support for meta-analytic reviews and book projects
- Collaborate with VPR on focused research excellence around interdisciplinary themes related to the distinctive academic missions of CSU
- Work with the College of Health and Human Sciences on new health-related programs consistent with our land grant mission: a 3+2 Nursing Program in collaboration with CSU Pueblo, a Doctor of Physical Therapy Program, and sports medicine offerings in collaboration with Orthopedic Center of the Rockies
- Campus master planning for academic and research space: advocate for VEHEC, Glover and a Laser Building; understand how academic space is allotted and make sure CSU is using academic space for highest strategic priorities
- Prepare students and faculty for a world driven by Artificial Intelligence – collaborate with VP of IT Brandon Bernier to sponsor a system wide task force and launch pilot projects
- Strengthen graduate education: new doctoral programs in areas of excellence and workforce need, expand professional master's programs to meet workforce needs and attract international students
- Strengthen faculty development: TILT, support for leadership development, CSU Writes

### **Institutional Competitiveness**

- Developed a draft Strategic Roadmap to be socialized with the CSU Community beginning in January 2025
- Budget model redesign – Serve on the Executive Sponsor Committee with President Parsons to lead a shared governance process to develop a hybrid RCM model for CSU (which currently uses an incremental budget model)
- Hired two outstanding Deans to lead CSU's Colleges of Liberal Arts and Agricultural Sciences, an excellent new Vice Provost and Dean for Undergraduate Affairs, appointed a strong Interim Dean to lead the College of Natural Sciences for 1-2 years
- Leadership Excellence – Strengthen leadership development for academic leaders and faculty and staff, help leaders promote collegial academic cultures, hired a Chief of Staff and Associate Provost for Organizational Strategy and Academic Leadership with strong expertise in executive coaching in higher education
- Engage Faculty Council to discuss making tenure and promotion procedures consistent across campus to promote excellence and equity and to have more faculty input after the department review – in collaboration with Faculty Council, in January of 2025 formed CSU's first University Promotions Committee of academic Deans plus one full professor from each college
- Collaborate to strengthen involvement of academic leaders in Advancement – partnered with Advancement on a workshop to help academic leaders understand their roles in engagement, cultivation, developing proposals, and stewardship
- Continue efforts in faculty and staff compensation – advocating energetically to prioritize faculty and staff compensation by hiring strategically and carefully considering capital investments

### **Outreach and Impact around the State and the World**

- Work with Enrollment and Access and Extension and Engagement to recruit more rural students to CSU

### **Administrative Accomplishments as Dean of the College of Health and Human Sciences (HHS), Purdue University (August 2018- October 2023)**

As the Dean of HHS, I led one of the largest colleges at Purdue University, comprised of nine diverse departments focused on understanding and improving human health and quality of life (Psychological Sciences; Health Sciences; Nursing; Speech, Language and Hearing Sciences; Public Health; Health and Kinesiology; Nutrition Science; Human Development and Family Studies; and Hospitality and Tourism Management, which includes a Division of Consumer Science). HHS is a distinctive college at Purdue; our faculty is 61% women, and our undergraduates are 76% women, 14% URM, and 20% First Generation. As Dean, I create the academic vision, oversee an overall budget of over \$114.7 million, and develop the talent of 5,762 students (5,030 undergraduates and 732 graduate students), 276 faculty members (177 tenured/tenure track and 99 clinical/professional), and 507 staff members. Since I began in August of 2018, HHS enrollment has grown by 16.3%. The 4-year graduation rate for HHS is 76%, as compared to 66% for the university. I have led the HHS tenure and promotion process for 76 faculty candidates: 55 tenure and tenure track and 21 clinical/instructional. HHS Extension educators work in all 92 Indiana counties to offer programming related health, food, family, and finances; HHS Extension oversees \$7 million in extramural funding to support programs for limited resource audiences in the areas of mental health and health equity, COVID-19 vaccine hesitancy and adult vaccination education, farm stress, and diet quality and physical activity. As an academic leader, my success results from collaboration with excellent colleagues. Accomplishments since beginning this role include:

#### **Vision, Innovation, and Strategic Planning**

- Led a college wide strategic planning process in 2019-2020
- To clarify the identity of this broad, dynamic college, led the development of three signature areas for HHS: Developmental Health and Wellness, Vital Longevity and Healthy Lifestyles, and Sustainable and Thriving Communities
- Co-chaired a campus wide working group to create a new Winter Flex term at Purdue, to foster student success by offering opportunities to take online courses and to study abroad
- Led a Purdue Deans' Working group on Innovative Excellence Post-COVID-19 and proposed creative changes for Purdue University's instructional models, research operations, engagement and partnerships, and organizational development and efficiency, many of which are being implemented now by our new President and Provost

#### **Raising the Quality of HHS Academic Programs**

- Led a realignment of academic programs in HHS – built consensus, sought and gained approval of all HHS units and college committees, the University Senate, the Provost, the President and the Board of Trustees, who approved the proposal in June of 2019, less than one year after I arrived
- Formed a new Department of Public Health in July of 2019 to provide this important area with a dedicated faculty and to make Public Health more visible in HHS

- Created a new Division of Consumer Science within our School of Hospitality and Tourism Management, to provide more faculty support for these important programs and to provide students more opportunities to learn from tenured/tenure track faculty
- Required that all HHS faculty members not in 100% administrative appointments teach at least one organized course per year, so HHS students have the opportunity learn from research active faculty
- Expanded access to undergraduate research opportunities
- Earned important national rankings for graduate programs from US News and World Report: #3 Speech-Language Pathology, #9 Audiology, #43 Clinical Psychology, #39 Psychology, #30 Best Nursing Schools: MS, #53 Best Nursing Schools: DNP

### **Building the HHS Research Enterprise through Faculty Development**

- Since 2018, invested over \$2.5 million in enhancing the HHS research enterprise
- Oversee a research portfolio of \$32,000,000 in research expenditures in 21-22
- Since 2018, increased NIH funding in HHS from \$11.7 million to \$16.2 million
- Hired a Senior Research Development Administrator (RDA) to bring together interdisciplinary teams to pursue major funding opportunities and to provide grant writing guidance
- Supported the Associate Dean for Research (ADR) and RDA in offering biweekly research meetings largely focused on grant writing, regularly attended by 30+ faculty members
- Appointed the first Associate Dean for Faculty Affairs (ADFA) in HHS to focus on faculty hiring and faculty development
- Worked with the ADR and the ADFA to create a professional development program for new Assistant Professors in HHS, to help them launch their research programs, teach well early, and understand research and business processes at Purdue
- Offered two writing workshops to HHS faculty and graduate students, led by Dr. George Gopen
- Developed a college wide Research Reinvestment Program, for equity and transparency in returning 25% of salary savings to a research allocation for faculty who put academic year effort on external grants
- Secured the assistance of Hanover Research for grant writing support
- Appointed faculty co-leaders to develop interdisciplinary research initiatives in our three HHS Signature Areas: Developmental Health and Wellness, Vital Longevity and Healthy Lifestyles, and Sustainable and Thriving Organizations and Communities

### **Diversity, Equity, and Inclusion**

- Since starting as Dean, increased the number of underrepresented students in HHS by 30%
- Proposed a university-wide, Equity Cluster hire in Public Health, Health Equity, and Health Policy to attract 14 faculty members to enhance expertise in diversity at Purdue that was supported by the Purdue Board of Trustees, provided matching funding, secured 9 of these positions for HHS, successfully hired 8 excellent scholars who started in Fall of 2022
- Serving as Lead Dean for Public Health, Health Equity, and Health Policy to advocate for resources and develop programming to foster the retention of these excellent scholars
- Served on the Deans' Council of the Purdue Board of Trustees Equity Task Force
- Reorganized and restructured HHS efforts in Diversity, Equity, and Inclusion, including creating unit level Director positions and appointing a college wide Associate Dean of Diversity, Equity, and Inclusion
- Prioritized faculty searches that highlight expertise in diversity, equity, and inclusion and required all Heads and members of search committees to attend a 90-minute HHS session on best practice for faculty hiring, resulting in hiring 41 faculty members in Fall of 2022, 12 of whom are faculty of color
- Created a student led program to build inclusion for diverse undergraduate, HHS Connex
- Devoted and remodeled a large space to serve as the HHS Connex Hub, student collaboration and study space with an emphasis on including and Belonging
- Expanded the HHS Connex program to include a summer program for new beginner, underrepresented students
- Requested that that Enrollment Management make diversity a criterion of highest importance and that SAT/ACT scores not be considered in HHS admissions

- With the support of our Associate Deans for Research, Graduate and Online Education, and Diversity, Equity, and Inclusion, offered three diversity graduate fellowships
- Funded graduate student created and led projects to advance diversity, equity, and inclusion in HHS

### **Development**

- In collaboration with our HHS Development team, raised over \$96 million for HHS (150% of Purdue's annual goals for HHS), including \$19 million from three large gifts for a building still in the planning stages
- Formed the first ever college wide Dean's Leadership Council for HHS
- Secured the first naming of an academic unit in HHS, the White Lodging-J.W. Marriott, Jr. School of Hospitality and Tourism Management
- Secured two named Headships
  - The White Lodging Services Head of the White Lodging-J.W. Marriott, Jr. School of Hospitality and Tourism Management
  - The Mark and Maureen Miller Head of the Purdue School of Nursing

### **Partnerships**

- Expanding our partnership White Lodging Services, building on our relationship with the Union Club Hotel at Purdue, the only student-run hotel in the Marriott Autograph Collection
- Working with McNair Living and Purdue for Life to build a VarCity Senior Living Community at Purdue, which will be fully integrated with academic programs at the university, including internships for HHS students in nursing, dietetics, hospitality, speech pathology, audiology, and athletic training
- With the College of Pharmacy at Purdue, advocated for a new Nursing Pharmacy Education building, currently the top capital project on the West Lafayette Campus, with \$89 million in cash recently appropriated in FY 23 by the Indiana Legislature
- Working with the IU School of Social Work and a local foundation, North Central Health Service to launch an IU School of Social Work in West Lafayette, which will provide important opportunities for our Purdue students to earn a Master of Social Work degrees and fill an urgent community need

### **New Academic Programs**

- Co-chaired a working group to establish a new Winter Flex term for Purdue University, which received a strong vote of approval from the Academic Senate and began in December, 2022
- Received approval from the Purdue Board of Trustees and Indiana Commission on Higher Education (ICHE) for a new Master's in Healthcare Administration
- Received approval from the Purdue Board of Trustees and Indiana Commission on Higher Education (ICHE) for a new thesis-based Master's of Public Health and a Ph.D. in Public Health

### **Leadership through the COVID-19 Pandemic**

- Served on the Medical Advisory and Tracking and Tracing Teams for the Protect Purdue Implementation Plan
- Supported the transition to remote learning/reduced research activities/telework for students and faculty in Spring 2020
- Provided financial support for over half of our faculty to obtain summer training to develop the highest quality hybrid and online courses for the 2020-2021 academic year
- Planned for budget reductions and transparently communicated these to faculty and staff
- Created a COVID-19 rapid response research funding program for almost immediate funding up to \$15,000
- Created a university wide Best Practices in Higher Education funding program with awards up to \$50,000 to support faculty experts in evaluating the effects of changes in instruction and advising necessary for reopening in Fall 2020
- Consistently communicated an emphasis on community health and compassionate support of faculty, staff, and students

- Conducted virtual forums in the Summer of 2020 to maintain communication, listen to concerns and raise morale, including Town Halls for faculty, staff, and graduate students, as well we three summer Forums on Excellence in Higher Education to discuss Michael Wesch's ideas on Teaching Without Walls, Kevin Gannon's book *Radical Hope: A Teaching Manifesto*, and William Deresiewicz's book *Excellent Sheep*

### Space Planning

- In collaboration with Ayers Saint Gross, led a space planning process for HHS, identifying our current need for 40% more additional space and proposing five new buildings to meet those needs
- In collaboration with the Dean of Pharmacy and Ayers Saint Gross, led a planning study for a new joint Active Clinical Learning Facility for the School of Nursing and the College of Pharmacy

### Restructuring the HHS Leadership Team

- Modified the Associate Dean structure to create separate positions for an Associate Dean for Research and an Associate Dean for Graduate and Online Education, in addition to a Senior Associate Dean for Undergraduate Research and Academic Affairs and an Associate Dean for Diversity, Equity, and Inclusion
- Appointed a new Associate Dean for Faculty Affairs in November 2021
- Restructured HHS efforts to advance Diversity, Equity, and Inclusion – completed a search for a new Associate Dean, appointed unit level faculty leads who form a college wide committee and who lead diversity committees in their own units
- Hired an HHS Online Program Manager to coordinate efforts to create and launch new online offerings

### Administrative Accomplishments as Dean of Graduate Studies and Associate Provost, UT Dallas (September 2015 – July 2018)

As Dean of Graduate Studies at UT Dallas, I provided oversight and support for 31 doctoral and 60 master's programs enrolling over 9,000 graduate students across our eight schools: Arts and Humanities; Arts, Technology, and Communication; Behavioral and Brain Sciences; Economics, Policy, and Political Sciences; Engineering and Computer Science; Interdisciplinary Studies, Management, and Natural Science and Mathematics. Below I highlight my most significant accomplishments in the three years I served as Graduate Dean, though of course these accomplishments are the results of collaborative efforts with excellent teams. In the period during which I served as Graduate Dean, the number of doctoral degrees awarded increased from 194 to 251 (an increase of 29%) and the number of master's degrees from 3530 to 3649 (an increase of 3%).

### Professional Development for Graduate Students

- In collaboration with many units across campus, organized the 1<sup>st</sup> and 2<sup>nd</sup> Annual Graduate Professional Week (29 workshops and professional development events for graduate students in 5 days)
- Launched a new program of Graduate Career Services
- Developed a Graduate Fellowships program to help all students find funding and to help some students seek distinguished fellowships
- Collaborated with the Office of Undergraduate Education on Research Week, a week of events to highlight and encourage the research efforts of graduate and undergraduate students at UT Dallas
- Developed a program of Graduate Writing Services
- Consulted with Dr. Paul Diehl (Director, Center for Teaching and Learning) on teaching related workshops for graduate students
- Implemented new Small Grants and Dissertation Research Awards, with priority given to those who have applied for external funding, to provide incentives for doctoral students to apply for external funding (see
- Continued to redesign and streamline the orientation offered at the beginning of each semester for new Teaching and Research Assistants

### Communication and Collaboration

- Redesigned the Office of Graduate Studies website
- Collaborated with many groups across campus to create excellent programming for graduate students, including but not limited to the Center for Teaching and Learning, the International Center, the Health

Center and the Student Counseling Center, and the Office of Undergraduate Education

- Responded to countless email inquiries from faculty, staff, and students about policies and procedures related to graduate education, supported faculty and staff in raising quality, encouraged students to work with their faculty program heads, and if necessary, to use our UT Dallas policies and procedures to address concerns
- Held open houses for Graduate Advisors across campus to convey our thanks for the excellent work they do with our graduate students and to strengthen our positive relationships with them
- Conducted monthly meetings of the Graduate Council and to attend monthly meetings of the Committee on Undergraduate Education, Committee on Educational Policy, the Academic Council, the Academic Senate, the International Partnerships Development Committee, and the university wide Committee on Effective Teaching
- Chaired an Academic Senate 3+3+2 Committee to examine the implementation of Title IX at UT Dallas

### **Modernization**

- Transitioned to electronic submission of Theses and Dissertations, requiring entirely new procedures and formatting manuals
- Developed a digital form for requests for exceptions to academic policies, increased accuracy in documenting approvals and eased the administrative burden on academic programs
- Moved to digital storage of all records in the Office of Graduate Studies

### **Policies and Procedures**

- In fall of 2017, took over leadership of all graduate program reviews for UT Dallas
- Continued to require that requests for exceptions and accompanying documentation be in writing
- Started only signing forms and exceptions that have already been approved by program advisors, program heads, and school level Associate Deans
- In consultation with the Graduate Council, continued to propose changes to existing policies to raise the quality of graduate education at UT Dallas (for example, allowing interdisciplinary dissertation committees, granting programs the authority to approve transfer courses and catalogue year changes)
- Held informational meetings to convey the importance of following our degree plans and policies

### **Graduate Student Recruitment**

- Organized Graduate Recruitment Fairs
- Enhanced digital application review systems
- Supported staff in attending professional conferences for recruitment

### **Increased Recognition of Excellence in Graduate Education**

- With the help of the Graduate Council, implemented the first ever Best Dissertation Awards at UT Dallas
- Assisted the Provost with the first ever Award for Sustained Excellence in Graduate Research Mentoring

### **Staffing**

- Hired and trained two new Associate Deans, a Director of Graduate Career Services, a Distinguished Fellowships Advisor, 2 Program Specialists, 3 Degree Plan Evaluator III's, an Assistant Graduate Reader, and two administrative assistants, while retaining the five members of Graduate Dean's team
- Developed a strong, united team excited to support the faculty in raising the quality of graduate programs

This new position in the School of Behavioral and Brain Sciences (BBS) was created for me by then Dean Bert Moore to work with the Associate Dean of Graduate Studies, the Associate Dean of Undergraduate Studies, and the Dean to make sure that School programs were maximally effective. The School of Behavioral and Brain Sciences includes 13 different degree programs organized into three primary areas: Cognition and Neuroscience, Communication Sciences and Disorders, and Psychological Sciences.

- **Implemented a new BBS structure** –drafted job descriptions for all administrative positions and support staff in the school, supported new Area Offices in Cognition and Neuroscience and Psychological Sciences, conducted ongoing consultation with faculty and staff to strengthen the new area offices and to make sure staff resources were utilized optimally, determined primary and secondary area affiliations for all faculty members
- **Strengthened faculty governance** – drafted and updated new BBS bylaws in consultation with the Dean, the Associate Deans, Area Head, and the BBS Academic Advisory Council; conducted elections for the BBS Academic Advisory Council and the Faculty Personnel Review Committee; maintained a current list of all BBS committees and supported the Dean and the Associate Deans in making new committee appointments each summer; assisted in preparation for meetings of the BBS Academic Advisory Council and the BBS faculty
- **Led faculty recruitment** – supported all faculty searches by working carefully on search processes and procedures, consulted with search chairs, encouraged efforts of recruitment of members underrepresented groups
- **Improved faculty evaluation** – communicated with Ad Hoc promotion committees each fall about procedures and timelines in BBS, assisted with preparing annual reviews of faculty, served as a BBS representative on the UTD Committee on Qualifications, assisted in developing promotion criteria for clinical audiology faculty

- **Augmented faculty mentoring** – offered additional mentoring to all new faculty in BBS, looked for every opportunity to support and encourage newer faculty members, offered to watch them teach and encouraged them to watch me, gave presentations to the university wide faculty mentoring program
- **Enhanced general operations** – improved procedures in several areas such as: scheduling of conference rooms and the computer classroom, staff relations, use of space, Academic Continuity planning; documenting existing policies and procedures (for example, the teaching load for new faculty)
- **Led special projects** – supported the development of the new BBS website, developed a BBS Associate Dean’s calendar with recurring yearly tasks and reminders, participated in planning meetings for the new Callier Richardson building addition, organized a yearly staff appreciation luncheon, planned events for post-doctoral fellows, investigated lecturer/senior lecturer titles, investigated graduate stipends at other universities, evaluated applications for undergraduate research awards.
